This information is requested in order for the Council of State to be able to determine whether or not the Dutch fees are exaggerated, or disproportionately high.

Municipal taxes are covered by municipal autonomy and therefore differ from one municipality to another.</p> <p>3. Amounts notified below are applicable as from 1 January 2014.
